Project Description

Find out about the proposed project to repurpose I-64 in both directions from approximately 1 mile east of the I-264 interchange to 0.4 miles west of the I-564 interchange in Norfolk. The three existing general purpose (GP) lanes and shoulders will be converted to one part time, high-occupancy express shoulder land and three GP lanes. The bridges over Tidewater Drive will be widened and rehabilitated, and the bridges over Chesapeake Boulevard will be replaced. Several existing bridges along the corridor will be rehabilitated and spot widening will occur


to accommodate the typical section along the corridor.

During construction, three lanes of traffic will be maintained in each direction. However, motorists should expect short duration activities that may require nighttime lane closures.

The project also includes:

- Drainage improvements
- Stormwater management facilities
- Shoulder rehabilitation/strengthening
- Possible noise walls
- Sign structure replacements
- Retaining walls
- Utility relocations

Environmental Review

In cooperation with Federal Highway Administration (FHWA), VDOT is evaluating the environmental impacts of the Hampton Roads Express Lanes (HREL) Segment 1A/1B in the City of Norfolk in the form of a draft Categorical Exclusion (CE) document.

The draft document includes information from various technical studies including those related to wetlands, threatened and endangered species, air quality and noise impacts. In compliance with the National Historic Preservation Act, Section 106 and 36 Part 800, information concerning potential effects of the proposed project on properties listed in or eligible for listing in the National Register of Historic Places is also provided in the environmental documentation.

The project will continue to be coordinated with appropriate federal, state and local agencies as part of various environmental review processes. All required environmental clearance and permits will be obtained prior to construction. Strict compliance with all environmental conditions and commitment resulting from regulatory approval, and implementation of VDOT's specifications and standard best management practices will protect the environment during construction.

Right of Way

The construction of the I-64 Express Lanes will require acquisition of right of way for spot widening and drainage facilities. Right of Way acquisition and utility relocation will be performed in accordance with the Federal Uniform Relocation and Real Property Acquisition Act and VDOT standards.

Displays at this meeting show the extent of right of way that may be needed as the project moves forward. As the final design is developed, additional easements and right of way may be required beyond what is shown on the plans. Property owners will be informed of the exact location of the right of way and easements during the right of way acquisition process prior to construction.

Information about right of way purchase is discussed in VDOT's brochure, "Right of Way and Utilities: a Guide for Property Owners and Tenants." Copies of this brochure are available here from a VDOT Right of Way agent.
